



TERMS OF AGREEMENT FOR A PUBLIC PERFORMANCE LICENSE

The following are the terms and conditions (“Terms and Conditions”) applicable to the Site Public Performance License as granted to each purchaser (“Licensee”) of a License for the “Generations at Risk” (“Film”). Licensee fully agrees and will comply with all the terms and conditions as set forth herein.

1. **License.** Tricord Media Inc. (“Tricord”) represents and warrants that it is the authorized Canadian distributor of the Film and thereby has the full power and authority, free of any rights of any nature by any other person, to enter into this license agreement and to grant the rights herein. Tricord hereby grants to Licensee a non-exclusive limited license (“Site Public Performance License” or “Original License” or “License” or “Rights”) to exhibit and perform the Film in any kind of movie night event, church service, ministry meeting, conference, bible study, small group, life group or gathering of people within one primary address of the Licensee (“Site”) and throughout the Term. Licensee hereby acknowledges that Licensee acquires no other rights except those expressly granted herein.
2. **License Confirmation Code.** A license fee shall apply under this License for the Licensee’s privilege of exercising the Rights granted herein (“License Fee”). Upon payment of License Fee, an appropriate license confirmation code (“License Confirmation Code”) shall be assigned to Licensee, as confirmation of purchase receipt of License. By Tricord’s issuance of the following Code (“Code”): _____ (retrieved Code from your receipt/purchase **order number**), Licensee herewith acknowledge payment of License with a Term that is take effect immediately (“Commencement Date”).
3. **Term.** This License shall have a term duration of **one year** (“Term”). In the event that Licensee wish to renew or extend Term, Licensee may do so by purchasing a new Site Public Performance License for an additional fee, under which the term duration shall be for one year.
4. **Conditions.** Licensee agrees to fully comply with the following conditions of License:
 - (i) DVD / Digital Copy (Video Stream) is not included and must be purchased separately.
 - (ii) Licensee may not exhibit Film at more than one primary address at a given time.
 - (iii) Licensee may exhibit the Film up to a total of **two event plays per agreed upon Date of Event**
 - (iv) Licensee may not edit, dub, and/ or alter Film in whole or in part (including credits, copyright notices and trademarks).
 - (v) Licensee may not make a copy of Film available to congregation or members.
 - (vi) Licensee may not copy, distribute, or transfer Film to other persons outside of Licensee’s organization.
 - (vii) Licensee may not use Film for any commercial purposes, including, but not limited to reselling, incorporating into commercial works, or packaging with any other products for sale.
 - (viii) Licensee may not exhibit, display, or broadcast through the internet, radio or television including, but not limited to Licensee’s website, YouTube, Vimeo, televised or streaming church services.
 - (ix) Licensee may not use Film to create derivative works either through including a portion, or all, of Film in new works or as a template, reference, or outline for new works.
 - (x) Licensee may not incorporate Film (or any part) into a logo, trademark, service mark or application thereof.

- (xi) Licensee may not carry out any other activity that are not expressly granted under this Agreement.
 - (xii) Licensee may not charge an admission fee or viewing fee for the public exhibition of the Film pursuant to this Agreement
 - (xiii) Licensee may not sublicense and/or assign any of the Rights, interest and/or obligations under this Agreement
5. **Proprietary Rights and Copyrights.** All copyrights related to Film are retained by the content producers and contributors of the Film. Licensee acknowledge that all right, title, and interest in and to the Film, including without limitation, any and all trademark, copyright, and any other intellectual property rights therein remain with the content producers and contributors and nothing contained herein shall be construed to convey any rights or proprietary interest in the Film other than the specific limited rights granted under this Agreement.
6. **Remedies.** In event of any unauthorized actions of the Licensee, Tricord reserves all legal rights and remedies, including the right to charge Licensee additional license fees as determined by Tricord in its sole discretion, with such payment to be made immediately due to Tricord.
7. **General.** This Agreement shall be governed by the law of the Province of Ontario and each party irrevocably and unconditionally submits to the non-exclusive jurisdiction of the courts of Ontario.
This Agreement constitutes the entire agreement between the parties. Any amendments may only be made by written agreement between the parties.
